### Syllabus Is Forthcoming

#### **Course Materials**

The textbook is Lisa G. Lerman & Philip G. Schrag, *Ethical Problems in the Practice of Law* (3d ed. 2012). The required supplement is Stephen Gillers et al., *Regulation of Lawyers: Statutes and Standards* (Concise Edition 2013). Students are allowed to buy an older edition of the supplement; used copies are available at discounted prices. If you choose to do this, you will be responsible for learning about any changes or updates made in the 2013 edition.
